2. \$0 virtual care (no cost share) for eligible preventive care and Dedicated Virtual Urgent Care for minor acute medical conditions. Not available for all plans. HSA plans and non-minor acute medical care may apply a copay, coinsurance or deductible. Cigna Healthcare provides access to Dedicated Virtual Care through a national telehealth provider, MDLive located on myCigna, as part of your health plan. Providers are solely responsible for any treatment provided to their patients.

3. Health benefit plans may be different, but in general to be eligible for coverage a drug must be approved by the Food and Drug Administration (FDA), prescribed by a health care professional, purchased from a licensed pharmacy and be medically necessary. If your plan provides coverage for certain prescription drugs with no cost-share, you have to use an in-network pharmacy to fill the prescription. If you use a pharmacy that does not participate in your plan's network, your prescription may not be covered or reimbursement may be limited by your plan's copayment, coinsurance or deductible requirements. Look at your plan documents for more information about your plan's prescription drug coverage.

4. Pediatric dental is not available in all states. Some states have stand-alone dental plans with pediatric services. Additionally, some states have a bundled pediatric dental option for off-Exchange consumers.

The Cigna Take Control Rewards program is available in all states to all primary subscribers who are active Cigna Healthcare medical Individual and Family Plan policyholders and who are 18 years of age or older. All rewards may be considered taxable income. Contact your personal tax advisor for details. Program participation along with reward redemption is dependent on qualifying premiums being current and fully paid.

6. The Reloadable Reward Card is just one example of what may be redeemed with earned points in the Cigna Take Control Rewards program marketplace. The Health Assessment must be completed on myCigna and all four behaviors associated with the Annual Wellness/Preventive Care tile on the Take Control Rewards site must be completed. Points for the Wellness Exam and A1C Test are applied 10-15 business days after the health care provider submits the claim and that claim is received by Cigna Healthcare. There can be significant delays with getting your points added to your balance as it depends on when your health care provider submitted the claim to Cigna Healthcare.

7. **Healthy Rewards programs are NOT insurance.** Rather, these programs give a discount on the cost of certain goods and services. The customer must pay the entire discounted cost. Some Healthy Rewards programs are not available in all states, and programs may be discontinued at any time. Participating providers are solely responsible for their goods and services.



# Three things to think about before making your choice.

## I. Cost

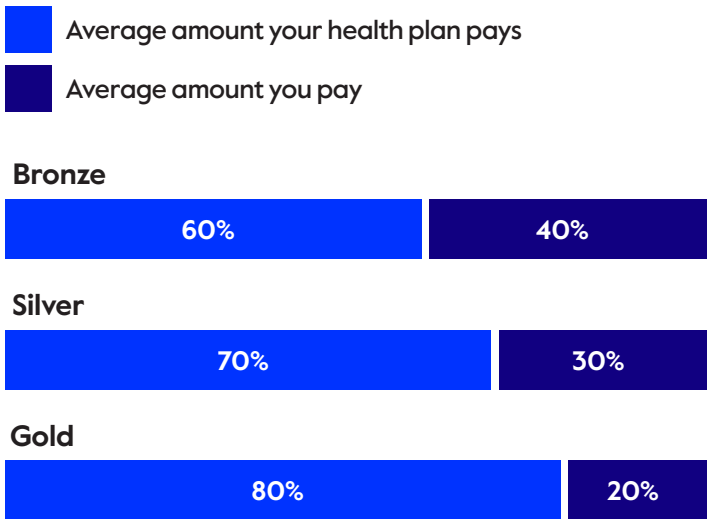
Choose a plan that fits your budget.  
Each plan has a variety of costs. These include:

- **Premium.** This is the payment you make each month to keep your coverage.
- **Deductible.** This is the set amount you pay out of pocket for covered medical services before your insurance starts sharing the cost.
- **Coinsurance.** Once you've met your annual deductible, you pay for a percentage of covered medical services and your health plan pays the rest.
- **Copays.** This is the fixed amount you pay for doctor visits, prescriptions or other medical services.

Cigna Healthcare offers a variety of plans, including some with a \$0 deductible and some with \$0 copays.<sup>8</sup> When choosing a plan, consider what's best for your budget and your needs.

## Plans are available in three metal levels.

Each is available on the Exchange and pays different amounts of the total cost of an average person's care. The higher the metal level, the more expenses your plan covers. ## 2. Financial assistance

Nearly 9 out of 10 Cigna Healthcare customers receive federal financial assistance when buying a plan on the Exchange.<sup>9</sup>

- **Premium tax credits** can reduce your monthly payment when you enroll in a qualified health plan (QHP).<sup>10</sup>
- **Inflation Reduction Act** helped 4 out of 5 new customers enroll in a plan for \$10 or less per month after federal financial assistance.<sup>11</sup>
- **Cost-sharing reductions** on Silver plans can lower the amount you pay out of pocket when you get care. Household size and income requirements determine the reduction amount. Cost-sharing reductions may be combined with a premium tax credit.

*Native Americans and Alaska Natives may qualify for tax credits and special cost-sharing reductions if specific requirements are met.*

## 3. Care and coverage

The Cigna Connect Network is a **Health Maintenance Organization (HMO)**, which gives you access to local providers selected with cost and quality in mind. To avoid extra expenses, make sure your current doctor is in-network or consider switching to one who is. To find out if your current doctor is in-network, visit [Cigna.com/ifp-providers](https://Cigna.com/ifp-providers).

### In-network

means the doctor or facility meets certain requirements and agrees to accept a discounted rate for services under your plan.

### Out-of-network

means the doctor or facility is not contracted with your health plan and can charge you full price for services.

Federal financial assistance can only be applied to the purchase of a Qualified Health Plan (QHP), which is an insurance plan that's certified by the Health Insurance Marketplace®, provides essential health benefits, follows established limits on cost-sharing (including deductibles, copayments and out-of-pocket maximum amounts) and meets other requirements under the Affordable Care Act (ACA).

## Frequently asked questions.

**Q Does the plan require a primary care provider (PCP)?**

**A** Yes, Cigna Healthcare Individual and Family Health Plans do require a PCP to be a part of your care team. Your PCP acts as your team leader, helping keep you healthy and coordinating your care. If you don't select one during enrollment, a PCP will be assigned to you. If you prefer a different PCP, you can easily change your PCP after your plan starts.

**Q What if I need urgent care but my PCP can't see me?**

**A** If your PCP is not available, you can still access quality care through another in-network PCP, at an in-network urgent care center, at a convenience care clinic or through virtual care. If you have a life-threatening emergency, go to your nearest emergency room (ER).

**Q How do I know if my prescriptions are covered?**

**A** You can find a plan-approved prescription drug list at [Cigna.com/ifp-drug-list](https://Cigna.com/ifp-drug-list).

## 2025 Important Plan Disclosures

Medical plan rates vary based on plan design, age, family size, geographic location (residential zip code) and tobacco use.

Rates for new medical policies/service agreements with a start date on or after 01/01/2025 are guaranteed through 12/31/2025. Thereafter, medical rates are subject to change on 45 days' prior notice.

Insurance policies/service agreements have exclusions, limitations, reduction of benefits and terms under which the policies/service agreements may be continued in force or discontinued. Medical applications are accepted during the annual Open Enrollment Period or within 60 calendar days of a qualifying life event. Benefits are provided only for those services that are medically necessary as defined in the policy/service agreement and for which the insured person has benefits.

The policy/service agreement may be canceled by Cigna Healthcare due to failure to pay premium, fraud, ineligibility, when the insured no longer lives in the service area, or when Cigna Healthcare ceases to offer policies/service agreements of this type or ceases to offer any plans in the individual market in the state, in accordance with applicable law. In the event of entry of a final judgment by a court declaring all or part of the Patient Protection and Affordable Care Act (P.L. III-148) invalid, unconstitutional, or otherwise ineffective, and the state not providing alternative and sufficient means of funding advanced-Premium tax credits, this policy shall be subject to cancellation consistent with applicable federal and state law. You may cancel the policy/service agreement on the first of the month following our receipt of your written notice. We reserve the right to modify the policy/service agreement, including plan provisions, benefits and coverages, consistent with state or federal law. Policies/service agreements renew on a calendar-year basis.
