<b>What is the overall <a href="#">deductible</a>?</b>	For <a href="#">in-network providers</a> : \$4,250/individual or \$8,500/family For <a href="#">out-of-network providers</a> : \$7,500/individual or \$15,000/family	Generally, you must pay all of the costs from <a href="#">providers</a> up to the <a href="#">deductible</a> amount before this <a href="#">plan</a> begins to pay. If you have other family members on the <a href="#">plan</a> , each family member must meet their own individual <a href="#">deductible</a> until the total amount of <a href="#">deductible</a> expenses paid by all family members meets the overall family <a href="#">deductible</a> .
<b>Are there services covered before you meet your <a href="#">deductible</a>?</b>	Yes. <a href="#">In-network</a> Office visits, <a href="#">Preventive care</a> , Independent lab, <a href="#">Prescription drugs</a> , <a href="#">Urgent care</a> , Outpatient mental health/substance use disorders office visits, <a href="#">Home health care</a> , Rehab/Hab, Child eye exam, Child glasses and Child dental check-up.
