If you have other family members on the <a href="#">plan</a> , each family member must meet their own individual <a href="#">deductible</a> until the total amount of <a href="#">deductible</a> expenses paid by all family members meets the overall family <a href="#">deductible</a> .
<b>Are there services covered before you meet your <a href="#">deductible</a>?</b>	Yes. In-network <a href="#">Preventive care</a> , PCP/ <a href="#">Specialist</a> visits, Ind lab, <a href="#">Prescription drugs</a> , <a href="#">Urgent care</a> , Outpatient mental health/substance abuse office visits, <a href="#">Home health care</a> , Chiropractic care, Child eye exam, Child glasses and Child dental check-up.
